A very remarkable scene was the landing of the first batch of Indian labourers, one well worth remembering. On Friday November 16.1860, the Truro dropped anchor in Port Natal and 341 Indians disembarked from it. "Spectators who ~~were~~^{were} present had been led to expect a lot of dried up, vapid and sleepy looking anatomies. They were disappointed - as the swarthy hordes came pouring out of the boat's hold, laughing, gabbering and staring about them with a very well satisfied expression of self-complacency on their faces." ¹

The overwhelming number of Indians who came here and eventually settled in this country, were indentured labourers and they made their contributions to the country's development, not only in canefields but also in various other fields.

Distinct from the indentured, was the second, small stream of immigrants. They were generally described, as "passenger Indians" who entered the country under the ordinary immigration laws, and at their own expenses. Majority came especially to trade and they opened their shops. They supplied goods, desired not only by Indians masses but also by Africans and Whites. The passenger Indians are culturally heterogeneous. They were mainly Gujarati speaking muslims and Hindus from Surat, Katihravar and Porbandar.

The Indian trader, in his ramshackle building was the first to set up a trading post in inaccessible parts of the country, transporting his goods by oxwaggon. First came the trader, followed by the usual number of hangers-on who supplied the need of the community. Then, the gradual tentative approach of the farmer and small holder who desired to be nearer his source of supply and everyday needs. Traders became the outlet for the farmers produces " just as they are today in many outlying areas.

"The coming of the Indians to Natal was no spontaneous uncontrolled movement. It was part of an elaborate system organised and controlled by the government of Great Britian and India."² The opportunity to migrate was also socially and legally restricted. The migration of Indians to South Africa was a selective process in which individuals and categories of people ^{were} ~~was~~ involved to migrate by promise of future rewards.

DURING the 1880's, Indians came to be a definite part of the country, prospering himself and helping the country to prosper.

J. Robinson reveals the following practical suggestions for the benefit of persons who may have determined to make this country their home:

- (1) A stout heart and a strong untiring arm.
 - (2) A temper prepared for disappointment, and determination to make the best of things.
 - (3) Sober habits and simple words.
 - (4) A conviction that the land before them is no paradise, and that in the new life they are to lead hard work; frugality and perseverance will be as necessary to success as they are elsewhere."³
- These qualities will stand a man in better stead than large capital and vast appliances. Both have been sacrificed in this country during times past, for the want of things.

My choice for this project fell upon the late Mr. Naran Hurrie. He originated from Bardoli, in the district of Varad in Surat, India. According to records, Mr. Hurrie was born during 1892 and he first entered the republic in 1905 and settled in Natal. His life has been characterised by outstanding events. However, he was called to rest on 20-5-1978. Free immigrants began to appear for the purpose of trade. Hindu traders came, many were Gujaratis, a community of which Mr. Hurrie was a member. Mr. Hurrie together with other traders, did well, indeed too well to please their white competitors. One cannot fail to mention, the controversial aspects that surrounded his experiences with regards to his name and marriage.

The socio-economic condition of Surat was declining. The area went through a year of famine and drought. Mr Hurrie's family lived on a farm where conditions were bad. The village life in parts of India was underdeveloped, stricken periodically by famine and ravaged by diseases. Hence industries had decayed with the importation of British goods and cloth. Some said, "We left at a time of drought and sickness; we had nothing to eat; our villages changed." The place was becoming overpopulated and living conditions in Surat was appalling.

Mr. Hurrie came to this country, with the sole purpose of trade to seek better prospects. But other reasons also motivated him to migrate. The conditions in South Africa was better as compared to his stay in Surat. Hilda Kuper substantiates this point when she states, "Promises of wealth, the currency easily forged by recruiters, was the most obvious inducement to migrate. The passenger Indians realized the economic potentialities of a young, developing country and families sent out one of their members to open a branch of an established business, or individuals came to try their luck."⁴

The passengers were more directly motivated by the desire and opportunity for economic prosperity. The atmosphere certainly influenced Mr. Hurrie to migrate to South Africa. Other reasons cannot be totally discouraged. The spirit of adventure and independence is negatively seen by conservative Indians, But there is evidence that a number of youth were prepared to break away from the family in a desire to 'see the world' and 'to do what they wanted.' This was the case of Mr. Hurrie, who wanted to "overcome the illtreatment rendered to him by his stepmother."⁵

A.N.Boyce states that "most of the Indians were living in poverty and immigration to South Africa meant an escape from the rigid caste systems of India."⁶ But Hilda Kuper, views immigration differently. "Indians did not immigrate to South Africa to escape any specific brand of persecution, political or religious, nor did they come in organised bands interested in creating any particular type of society."⁷

Mr. Hurrie left India on board the Kara Gola and arrived at Port Natal in 1905. Some indentured Indians, including some of the leading merchants entered without permits when immigration was restricted. This was the plight of Mr. Hurrie who came as an illegal immigrant with the help of his uncle. Thus he derieved the name of Mr. Naran Hurrie Pema. However, in 1927, the system of condonation was passed. Strinvasa Sastri, Agent General for Indians in South Africa, persuaded the South African government to condone the unlawful entry of Indians and hence they are described as condonees. They were permitted to remain but their permits can easily be withdrawn at any time . Indians poured into the country but they began to acclimatise themselves. Though very badly off they were not so utterly sunk in poverty as many of them had been in India. It is noteworthy that after some time they felt sufficiently settled. By 1905 , when Mr. Hurrie came to Natal, there were 100,918 Indians.

into the Province of Natal, is condoned
and he is permitted to remain in the said Province.

CONDITIONS AND REQUIREMENTS.

1. This permit is issued subject to the following conditions and requirements and to the provisions of the Immigrants Regulation Act, No. 22 of 1913, as amended by Act No. 37 of 1927, and the regulations thereunder:—

- (a) This permit is valid until it is cancelled by the Minister.
- (b) This permit preserves to the holder all the rights and privileges enjoyed at the date of commencement of Act No. 37 of 1927, viz., 5th July, 1927, and the holder is regarded as having entered the Province of Natal in terms of section *twenty-five* of Act No. 22 of 1913, except that he will not be permitted to claim the rights and privileges conferred by section *five* (f) and (g) of the said Act, that is to say that if his wife and/or children have not been admitted at date hereof he will not be permitted subsequently to introduce any of such persons.
- (c) This permit entitles the holder to retain any registration certificate, certificate of domicile, or other document authorizing him to enter, reside, or remain in the Union or any Province thereof, provided that if this permit is cancelled by the Minister such document or documents shall be dealt with under the provisions of section *ten* of Act No. 22 of 1913, as amended by section *five* of Act No. 37 of 1927. The documents referred to in this paragraph are as described below, viz.:—

- (d) The Minister undertakes not to cancel this document unless the holder is, subsequent to the 5th July, 1924, convicted of an offence as specified in section *twenty-two* of Act No. 22 of 1913 as amended by Act No. 37 of 1927. In the event of cancellation the holder shall forthwith be dealt with in terms of section *ten* of Act No. 22 of 1913, as amended by section *five* of Act No. 37 of 1927.

Mr. Naran Hurrie came to Natal and settled in Verulam. Verulam was the chief township of Victoria Country. There was at all time a calm contended air about the main street of the village, as though inhabitants were busy about their own concerns. The Indians enjoys the right to engage in free enterprise and he jealously guards his individuality be he farmer or fiancure. He is not looking for charity - he is looking for trade and he deseves to find it. Mr. Hurrie found his trade in this small village of Verulam. Verulam was his first and last place of settlement. His first occupation was that of a Hawker. He carried lucrative trade in the sole of vegetables. He supplied markets and the inhabiant, with vegetables, bought from small farmers, and transported by oxwaggen. However, Mr. Hurrie's occupation changed several times from a Hawker, he became a tearoom owner. This building still stands in Verulam. Mr. Hurrie then opened a barber shop. Today, his barber shop still survives under the name of 'Saloon Imperial', situated in the main street of Verulam. The shop is controlled by his son, Mr. Takoordas Hurrie.

The sole purpose of establishing shops was to serve the settlement of Indian workers on sugar lands. The shops were near as possible to the people they served, particularly on the North Coast.

Mr. Hurrie together with other traders have survived the deepest depression, such as that which descended upon the country in the early 1930's. But more than that they have survived countless other disabilities as groups. "It is not difficult to visualize the life of the earlier settlers, few in numbers, and feeble in influence, but rich in character and determination bounded together as friends and fellow traders, and sharing common hardship and adventures of life inseparable from earlier settlement."⁸ The trading situation within the union today, therefore stands as a natural outcome of the honourable ancestors who laid down the foundations.

At the time of Mr. Hurrie, it had become a recognized practise to have their children married in India. "Mr. Hurrie's marriage life was heartbreaking. He went to India to find a wife. His wife fell ill and died on the ship."⁹ Unfortunately, things looked bleak for Mr. Hurrie because of the restriction on immigration. Although, emotionally disturbed by the event; he applied for a permit to visit India. This was granted and he departed to India where he married Kassibaye Vullab. She was born in the year 1911 and originated from Surat. She arrived in Natal on 27 July 1927. They were married in the community of property and had four children.

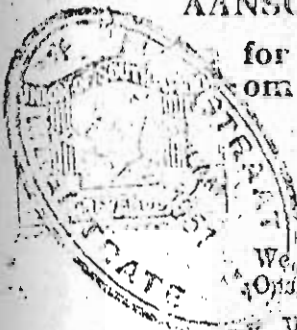

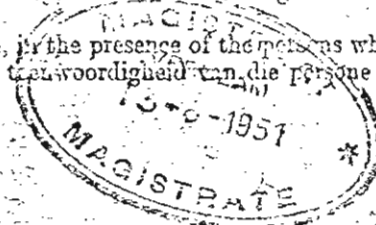

CHAPTER 4

Mr. Hurrie lived through the riots of 1949. The riots which burst out like a thundercloud aroused out of the hostility between the Bantu and Indians. They suffered times of hardship in many respects. Prices were rising and the Africans found that Indians Storekeepers with whom they dealt were demanding greater increased prices. Therefore there grew among the Africans profound irritation against the Indians. This together with other reasons ^{facilitated} ~~facilitated~~ in 1949 riots.

The Hurrie family recalled the riots which were experienced by Mr. Naran Hurrie. Their home was situated in the main street and was subjected to much damage. They always lived in fear and in darkness. However, they were still in the danger of being harmed by the rioters. Houses were burnt by the scores many Indians women and girls were raped by infuriated Africans and bands of Africans armed with knob knerries ran through the effected areas. One notably fact that came out from the interviews was that the police generally arrived after the rioters had left. R. Mabel describes what the whites did, "They gathered outside office windows, and balconies watching the scene, regarding it with amusement. One white man commented, "I am for the natives, serves the coolies right."¹⁰

It has sometimes been asked why the natives attack was delivered

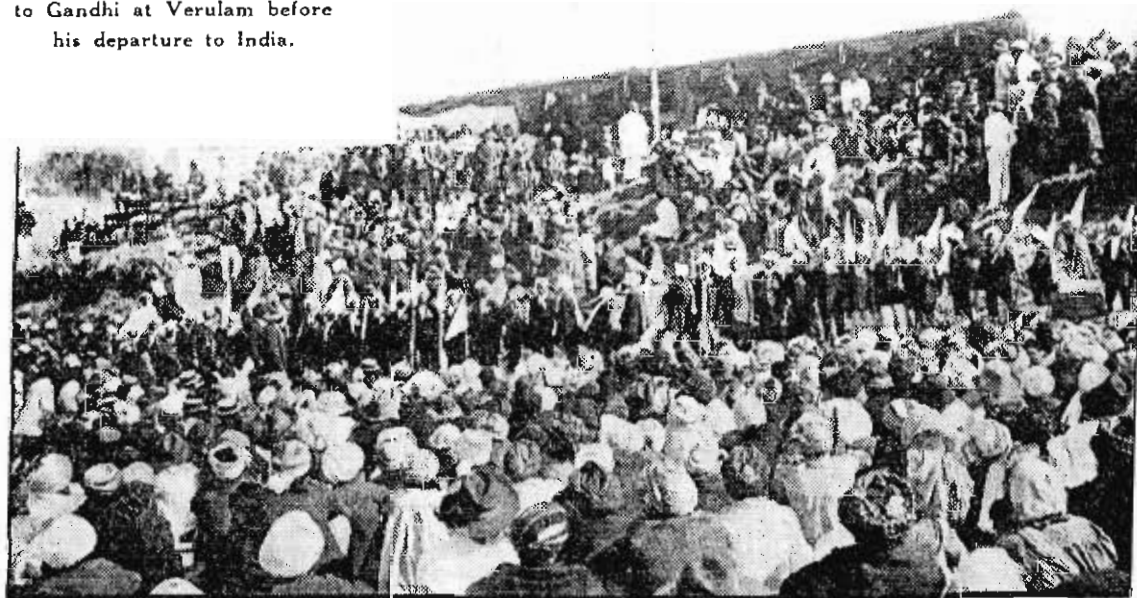

against the Indian and not against the whites. In fact it is the white man who is to be blamed for the inadequate and crowded transport, for bad housing conditions and if they were not to blame for the shortage of goods and high prices, the regulations designed to deal with the situation were the work of europeans. However, from the natives point of view it was the Indian with whom they were in contact and who represented the injustice of the situation.

Mr. Hurrie was a very religious person and maintained his religion at all times. He always stressed the importance of religion to his children. This is obvious, because "the only community organized on caste division and adhering to traditional caste at all strictly, was the Gujarati speaking of which Mr. Hurrie was a member." The persistence of caste among the Gujarati Hindus flows from their passenger status and their greater economic freedom. They did not come on ships with the indentured. They could easily afford to bring their families with them, and they retained contact with their caste through business or marriages.

Mr. Naran Hurrie was lucky to meet Gandhi. Gandhi arrived in Natal and boarded a train to Verulam. He was greeted by thousands of people at the Verulam station. A welcome ceremony was held in Verulam

One amusing but true fact according to the interviews, was that Mr. Hurrie was the first person to cycle a bicycle in Verulam. When it came to dressing, Mr Hurrie was always neatly clad in a black suit with a white silk shirt.

Mr. Naran Hurrie was a pioneer of Verulam. From the time of his settlement in Verulam till his death, he revealed his sound qualities of determination, hope and courage. He suffered from Haematemesis which eventually lead to his death on 20/5/78. . Then three months later his wife, Kassebaye Vullab was called to rest on 6/8/78.

CHAPTER 5

In the course of time, however, various changes naturally began to take place. So after 120 years of settlement in the land of their birth and adoption, vast differences have set in. Great changes have taken place in social and cultural system as well as in their material form of existence. The Indians have done much as operatives, to build up the industries of Natal, and this has, perhaps in recent years been the greatest contribution to the colony's economy. In general they are industrious and regular workers and the land is rich for their presence. "Though often disliked and sometimes hated by the African, They have as traders exercised a perceptible civilizing influence on them. From the white man they have learned much. Although they may have seemed in theory unassimilable they have in fact been assimilated to a surprising degree."¹²

Against all the restraints placed upon them, the Indians have brought their abilities, their enterprises, and a risk taking determination to succeed, of which they may well be proud of. Indians have become an accepted and permanent part of South African population. In fact, in every field of activity, the Indians will be faced with further exciting challenges. He will no doubt meet these challenges just as his forebears did and who, to everlasting credit, overcame them under conditions

INTERVIEW WITH MR. TAKOORDAS HURRIE

XX

1) WHAT IS YOUR RELATIONSHIP TO MR NARAN HURRIE?

Father.

2) YOUR FATHER'S NAME-IF ANY OTHER

My father was known as Mr. Naran Hurrie. However, when he first came to this country, he was known as, Mr. Naran Hurrie Pema. The name Pema was derieved from his uncle, who helped him to immigrate. Therefore, various docements reveals both these names. But his correct name was Mr. Naran Hurrie, which appeared on his Marriage Certificate as well as his Death Certificate.

3) WHERE WAS HE BORN AND IN WHICH YEAR?

He was born in Barlod, in the district of Varad, Surat, India. I don't know the exact date of birth, but it was during the year 1892.

4) WHAT WAS THE LIVING CONDITIONS OF SUTRAT AT THAT TIME?

Well, his parents was farmers in Surat. There was a severe drought that took place. People lived in poverty. Surat was struck by a decline in almost every aspect of living conditions. The district from which my father came was in fact a small village. The place was overpopulated and things were looking very bad. The industries could not survive and had to close down eventually. This lead to

widespread unemployment. Because of overpopulation, the place was plagued by diseases.

5) WHY DID YOUR FATHER LEAVE HIS COUNTRY?

Conditions were bad in India, Many people left the country to escape these conditions. My father decided to immigrate for the purpose of business. There was better prospects in Natal and he wanted to try his "luck." News was spreading in India that the living conditions in South Africa was better than that of India. Another reason that motivated him to come to this country was his domestic problem. His stepmother illtreated him and my father decided, that it would be better to immigrated to another country.

6) WHAT WAS THE NAME OF THE SHIP HE CAME ON AND THE DATE OF ARRIVAL?

He came on board the Kara Gola.

It arrived at Port Natal in 1905.

7) CAN YOU REMEMBER ANYTHING ABOUT HIS IMMIGRATION?

Not much, but my father came to Natal as an illegal immigrant, with the help of his uncle, Mr. Pema. He came as a "free Indian" and not as an indentured labourer. His stay in Natal was unlawful. The authorities found out that there were number of illegal immigrants in the country. They then passed the system of condonation whereby, Mr. Hurrie was permitted to remain in the country.

8) WHERE DID HE FIRST SETTLE AND WHAT OCCUPATIONS DID HE PURSUE?

My father came to Verulam and settled here. He was a pioneer of Verulam. His house was situated in the main street of the town. At first, my father was a Hawker. He bought vegetables and fruits from the orchards and sold them to the inhabitants. The transportation was made available through oxwaggon. My father then owned a tearoom, in Verulam. The tearoom business was booming. He was a very rich man but he did not know how to spend it. Eventually, my father opened up a barbershop, a trade which I am still following today. His business which is on my name, is managed as 'Saloon Impreal'. This Saloon is situated in the main street of Verulam.

9) DO YOU REMEMBER ANY POLITICAL ACTIVITIES?

No. However I do remember his voting experiences. My father voted for the Blacks as well as the Whites. According to local authorities, he could vote. He was paying his tax and he was a resident of Verulam, so it is only fair that he votes.

10) DID YOUR FATHER EXPERIENCE THE 1949 STRIKES THAT TOOK PLACE IN NATAL

He certainly did. Hostility grew between the Africans and the Indians. Indians sold their goods at high prices. In 1949, Africans began assaulting Indians, burnt down houses and destroyed trading centers. My father stayed in the main street and Africans used to surround the

the place and cause damage to the building.

11) IS THERE ANYTHING YOU FEEL THAT IS APT TO DESCRIBE HIS SOCIAL LIFE?

My father was at all times admired by the community. He attended many social gatherings. I must say that my father was the first person to cycle a bicycle in Verulam. Many teachers still remember this fact. My father met Gandhi at the Verulam Station. My father was always neatly dressed. His famous colours were black and white. His shirts were imported from London.

12) WHAT CAN YOU SAY ABOUT HIS MARRIAGE LIFE?

My father went to India to marry. He found himself a bride and was on his way back to Natal. His wife fell ill and died on the ship. My father tried to go back to India to find another wife. Restrictions were rigidly applied and my father had to get a permit to go to India. The permit was granted and he left for India. He visited Surat, where he married Kassebaye Vullab and brought her to Natal as his wife.
